

Terms and Conditions for the Vertiv™ Power Up this Spring Promotion– RESELLER



1. GENERAL

The Vertiv™ Power up this spring Promotion (the “*Promotion*”) is a promotion offering rewards to individual resellers to earn rewards by purchasing any product from the Vertiv Liebert GXT5 product line during the specified Promotion Period.

2. PROMOTION PERIOD

The Promotion begins on 1st April 2023 and ends on 30th June 2023 (the “*Promotion Period*”)

3. ELIGIBILITY

- **VIP-registered resellers:** the Promotion is open to all resellers who are duly registered with the Vertiv Incentive Program (the “*Eligible Resellers*”). Non-registered resellers can participate in the Promotion upon registration within the VIP Portal. In this case, Bonus Points will be credited after registration.
- **Eligible Products:** the Promotion is only available for upon purchase of one or more products from the Vertiv Liebert GXT5 product line during the Promotion Period (the “*Eligible Products*”).
- **Purchase from Vertiv authorized distributors:** the Promotion is applicable when buying Eligible Products from Vertiv listed distributors (a “*Distributor*”). The list of Distributors for your region can be found [here](#).
- **Minimum quantity:** a minimum of 1 product from the Vertiv Liebert GXT5 product line can be purchased to qualify for the Promotion. One purchase only within the promotional dates per customer. The 100 Bonus Points are available once, regardless of the quantity ordered or the number of orders. This promotion is valid to the first 50 resellers that purchase a GXT5 within the promotional period.

4. PROMOTION RESTRICTIONS

Other SKUs/product families than Eligible Products are not eligible for the Promotion. This Promotion is subject to product availability and is only available whilst distributor product stocks last. This promotion applies to the first 50 purchases only.

This Promotion cannot be combined with any other incentives that may be available to resellers under the Vertiv Incentive Program. Only one Promotion reward of 100 Bonus Points will be awarded per reseller, regardless of the number of orders or quantity of products ordered.
